5.	The Buyer will be offered a full refund or replacement puppy if the Seller is provided with a veterinary certificate indicating that the puppy/dog is in poor health and returned within 3 business days (Monday to Friday) of purchase.				
6.	The puppy/dog is healthy at the time of sale and has had immunizations enumerated by the included health record.				

- 7. If the puppy is diagnosed with **moderate to severe hip dysplasia** or **epilepsy** within 48 months of purchase, and the Buyer substantiates that there is likely no environmental cause (Ex: over-medication, poor nutrition, excessive play, or injury), the Buyer is eligible for a replacement puppy for no additional charge. In such a case, the Buyer is NOT required to surrender the original puppy/dog.
- 8. If at any time the Buyer is unable to keep or care for the puppy/dog, it must be returned to the seller WITHOUT compensation. The puppy/dog MAY NOT BE SENT TO A SHELTER OR RELOCATED. The Seller will aid the Buyer in the appropriate placement if the buyer intends to rehome the puppy/dog.
- 9. The Seller in no way guarantees that this puppy/dog shall:
  - Win conformation or performance events.
  - Present any physical or temperamental traits that are not evident at the time of purchase.
- 10. The Seller agrees to provide consultation to the Buyer for the duration of the puppy/dog's life.
- 11. If the Seller determines that the puppy/dog has been abused in any way, the Seller reserves the right to take full possession of the puppy/dog, and its duly signed transfer papers/registration, without compensation.
  - \*\*No other warranties or guarantees, expressed or implied, are made under this contract except as stated above.

## **Buyer Agreements**

- The buyer agrees that if at any time, and for any reason, he/she is unable to keep or properly care for the puppy/dog, it shall be returned to the Seller and no one else.
- 2. The Buyer understands that money deposited toward the purchase of a puppy/dog is transferable, but NOT refundable unless otherwise dictated by the Seller's discretion.
- 3. The Buyer agrees to maintain the puppy/dog's good health. Should the puppy/dog become ill or unsound, any costs of treatment will be the responsibility of the Buyer.
- 4. The buyer is responsible for the continued care, containment, training, and enrichment of the puppy/dog. As such, the buyer agrees not to sue the seller over matters and events concerning the puppy/dog after the transfer of ownership. Should any suit be brought against the seller regarding this puppy/dog by any person, the buyer agrees to pay any court fees incurred by the seller.
